- You are entitled to appoint a proxy or proxies, who need not be a stockholder of the Company or Deepa Kalikiri and Jon Prideaux, to exercise all or any of your rights to attend, speak and vote at a general meeting of the Company. If you wish to appoint a person other than Deepa Kalikiri and Jon Prideaux, please insert the name of your chosen proxy holder in the space provided. If no name is inserted in the space provided, Deepa Kalikiri and Jon Prideaux will each be deemed to be your proxy. You must follow the appointment procedures set out in these notes.
 - You may appoint more than one proxy provided each proxy is appointed to exercise rights attached to a different share or shares (except if your proxies are Deepa Kalikiri and Jon Prideaux, who may exercise rights attached to the same shares if appointed as your proxies).  - To be valid, this proxy form must, subject to note 8 below, be signed, dated and lodged, together with the original power of attorney or other written authority (if any) (or a duly certified copy of such power or authority), no later than 1.00p.m. on 20 May 2019 (or 48 hours before the adjourned meeting at which the person named on the form is proposed to vote) with the Company’s registrars, Link Asset Services PXS 34 Beckenham Road, Beckenham, Kent BR3 4TU.
 - If a stockholder is a company, this proxy form must be executed under its common seal (or such form of execution as has the same effect) or executed on its behalf by a duly authorised officer of the company or an attorney for the company. A copy of the authorisation of such officer or attorney must be lodged with this proxy form. You may register your proxy appointment and instructions online by visiting Signal Shares, www.signalshares.com, selecting BOKU, INC. and following the instructions. In order to register your vote online you will need to enter your Investor Code which appears on the your share certificate.
 - In the case of joint holders, any one holder may sign the form of proxy but all the names of the joint holders should be stated on this proxy form. The vote of the most senior holder who tenders a vote whether in person or by proxy shall be accepted to the exclusion of the votes of the other joint holder(s) and for this purpose seniority shall be determined by the order in which the names of the joint holders stand in the register of stockholders of the Company in respect of the joint holding (the first named being the most senior).
